

United States Sugar Savannah Refinery LLC "GUESS THIS HOLIDAY DISH" CONTEST 2023

United States Sugar Savannah Refinery LLC's ("Sponsor") Guess This Holiday Dish ("Contest") begins at 10:00 am Central Time ("CT") on Monday, November 6, 2023, via its websites and ends at 11:59 pm CT on Monday, November 13, 2023 ("Contest Period"). This Contest shall be subject to these Official Rules and, by entering, all entrants agree to be bound by the terms and conditions herein.

ELIGIBILITY:

Contest is open to legal residents in the fifty (50) United States and the District of Columbia, except residents of the state of Rhode Island, who are at least eighteen (18) years old. Employees, officers, directors and agents of United States Sugar Savannah Refinery LLC and their respective parents, subsidiaries, affiliates, promotion and advertising agencies and members of their immediate family (spouse, parent, sibling or child and their respective spouses, regardless of where they reside) and persons living in the same household of such employees, whether or not related, are not eligible to enter or win a prize. - 3. Entrants will search the Thanksgiving Recipes section of the Imperial Sugar website at https://www.imperialsugar.com/thanksgiving or the Dixie Crystals website at https://www.dixiecrystals.com/thanksgiving to find the recipe that matches the zoomed in image on the contest page.
- 4. Once the correct recipe has been identified, copy and paste the URL (web page address in the top bar of the page) of the correct recipe into the contest form on https://www.imperialsugar.com/contests/guess-this-recipe-2023 or https://www.dixiecrystals.com/contests/guess-this-recipe-2023.
- 5. Complete the entry form and submit.
- 6. Entrants will have until 11:59 p.m. CT on each night of the contest (11/6/23 11/13/23) to complete the form.

RULES:
